

The future of Vocational Training



- 25 million unemployed, 135 million in informal employment
 - 30% of population below poverty line
 - 18% average youth unemployment
- Academic education as training for work
- Align education to productive development policies
 - TVET is key element in National Development and in the productive development process. Thus the capability of emerging nation status in Science and Technology is a critical element to future growth and development. In a world increasingly dominated by Science and Technology, lip service to these branches of knowledge can not suffice.
 - The impact of developments in: Computer and Information technologies, Environmental Science, Micro-electronics and many others, challenge us to develop the capabilities of our own Caribbean people' Technical and vocational education and training is a method of developing these capabilities. (1990 Regional TVET Strategy)

Human Talents and Development



- Quality education measures the chances of employment
 - Correlation between the size of the enterprise and employee education
 - Micro-enterprises 15%
 - Small and Medium-sized enterprises 65 %
 - Large enterprises 50%
- Future vocational training
 - New occupations / production system (Industry 4.0)
 - Convergence of technologies (Distributed manufacturing)
 - Employment and wages High Vs Low-skilled
- Observed differences in access to quality education for low, middle and upper income youth
 - Increasing dropout rate

- Skills anticipation to manage skills uncertainty
- The role of enterprises as learning places
 - (Work-based learning: Apprenticeship, internship etc.)
- The coordination between formal education and vocational training
- Aligning training with productive development policies
 - Upgrading of institutions to technology centers
- Increase the use new educational technologies
