The ILO project "Technical support to ESIS for improving and expanding access to health care services in India – A transition to formality" (henceforth, ILO-ESIS project), supported by the Bill & Melinda Gates Foundation (BMGF), is disseminating the report on "Extending Social Health Protection to Informal Sector Workers in India: A Survey Report" prepared jointly by Institute for Human Development (IHD) and ILO DWT/CO-New Delhi on 23 November 2022, 10.00 AM to 1.20 PM IST.

## **Background**

### Social Health Protection

Countries across the world have been advancing towards Universal Health Coverage over the last few decades. Institutions of Social Health Insurance (SHI) have led the way in realizing the Sustainable Development Goal (SDG) 3 - "Ensure healthy lives and promote well-being for all at all ages".

## **ILO's framework**

The International Labour Organization (ILO) focuses on social health protection as part of its larger goal of developing strong Social Protection Systems to increase resilience, contribute preventing to poverty, unemployment, and informality. The ILO lays special emphasis on the financial protection of vulnerable working populations accessing health services. ILO has been working with governments in combining health interventions with social protection measures, so they can respond effectively to crisis such as COVID-19. This is indeed a core pillar of our response to the health and economic crises emerging from this pandemic. We believe that countries with a large informal economy should hold extension of protection to those not yet covered, including the 'missing middle', at the centre of their policy efforts.

## ILO-ESIS Project in India

The ILO in India, through the ILO-ESIS project, has been contributing to this goal by providing technical support to the Employees' State Insurance Corporation (ESIC) to strengthen its health services while increasing coverage and financial protection of working people in India. While studying ESIC's core social health protection role, the ILO has also developed a technical resource document "Extending Social Health Protection to Informal Sector Workers in India: A Survey Report". The broad objective of this study is to analyse the potential of upscaling the Employees' State Insurance Scheme (ESIS) services for the inclusion of economic units and workers from the informal sector to mitigate the health-related financial burden on households. The study focuses on those enterprises and workers who are currently eligible for the ESIS (but not covered), as well as those who are not eligible but may have the willingness to participate and the capacity to contribute.

# The Study: Extending Social Health Protection to Informal Sector Workers in India

The study was conducted by the research team at IHD in three phases across four states viz. Rajasthan, Haryana, Kerala, and West Bengal with a sample size of 4045 (2420 in phases 1 and 3 and 1625 in phase 2). It focused on three groups - enterprises eligible but not affiliated to the ESIS and workers therein; enterprises not eligible but with the capacity to contribute and workers therein; and third, workers not covered under the ESIS in affiliated enterprises.

## **Main Findings**

Main findings of survey results consist of three aspects: Understand the employers' perception, understanding the workers' perception and impacts of COVID-19.

The survey results show that the employers' knowledge and understanding on ESIS and other social health protection schemes were rather limited: merely 17 per cent of the employers claimed to know something about the ESIS and only 10 per cent knew something about the government social health protection schemes.

Concerning the perspectives of workers' on health protection, *33 per cent of workers had health protection benefit of some kind* (30 per

cent state schemes; 3 per cent central scheme). Of the workers covered by health insurance, **10** *per cent paid a certain contribution towards the scheme*.

Regarding awareness of ESI Scheme, 21 per cent of the workers had full or partial knowledge about the ESIS, higher in women as compared to men. 63 per cent workers were interested to participate in the ESIS and make the necessary contribution. The workers strongly felt the need for health protection and opined that the employer/contractor should bear the onus of medical coverage for their employees.

Trade Unions' roles and actions to enhance health protection to the workers are rather limited. The study reports only 3 per cent of the establishments experienced trade unions negotiating for individual employees' health and well-being in the event of workplace accidents and/or serious ailments.

Concerning the impact of COVID-19, a massive loss of livelihood and wellbeing of enterprises and workers has taken place. Small enterprises and workers were the hardest hit and continue to be the most vulnerable to such shocks. Realising the impact of COVID-19 pandemic, two out of three enterprises (67 per cent) were willing to join the ESIS for health coverage protection scheme in case additional concession/benefits were provided.

73 per cent felt the need for protective health measures against such diseases to ensure availability of quality health services, limit out-of-pocket payments to a minimum and increase accessibility to health-care facilities. Majority of workers preferred the workplace-based government/public scheme (65 per cent).

## **ILO Panel Discussion**

ILO has planned a panel discussion for knowledge-exchange on the study: "Extending Social Health Protection to Informal Sector Workers in India: A Survey Report". The objective is to expand the discussion to expand the coverage particularly to informal sector workers based on the report findings.

The knowledge-sharing by the experts and stakeholders in this programme is expected to contribute to India's ongoing endeavours of expanding health protection coverage to the informal sector workers.
