



# India Factsheet SCORE Programme Phase III

**Sustaining Competitive and Responsible Enterprises (SCORE)** is an ILO global programme that improves productivity and working conditions in small and medium enterprises (SMEs). The key intervention of the global programme is support for the implementation of SCORE Training, which combines practical classroom training with in-factory consulting.

Managers and employees are trained together with a focus on improving workplace cooperation and the programme ensures that both men and women participate. SCORE Training demonstrates best international practice in the manufacturing and service sectors and helps SMEs to participate in global supply chains.



SCORE Training in Phase II focused on the Light Engineering and Garments sectors

SCORE Training focuses on developing cooperative working relations resulting in shared benefits. The ILO is assisting government agencies, training providers,

industry associations and trade unions in emerging economies in Africa, Asia and Latin America to offer SCORE Training to enterprises. The ultimate outcome for the SCORE Programme is to have national institutions independently providing SCORE Training to SMEs to improve working conditions, productivity, and competitiveness.

SCORE Training is made up of 5 core modules, delivered through a combination of classroom training and in-factory consultancy and led by industry experts. The consultancy visits are a unique element of the training methodology that ensures that classroom learning is put into action in the workplace.


### **About SCORE India**

Over the two phases of the project, SCORE Training in India has raised awareness on productivity and working conditions together with the Stakeholders and Implementing Partners. In 2014, the ILO Country Office for India and the Federation of Indian Chambers of Commerce and Industries (FICCI), ILO's employer partner in India, entered into a partnership to institutionalize SCORE Training.

In addition, in 2014, The Ministry of Micro, Small and Medium Enterprises (MoMSME) and the ILO signed a five- year Memorandum of Understanding (MOU), in support of the Government of India's "Make in India" initiative; to create more and better quality employment in India. The MoMSME decided to embed SCORE Training in its Lean Manufacturing Competitiveness Scheme (LMCS) through a pilot roll-out in 10 Make in India clusters.

The cost recovery over Phase II averaged at 44% compared to 30% in Phase I, with the cost recovery in 2018 at 62%.

Over 100 SMEs have received SCORE Training so far.



## Phase III (2017 – 2021: Global and 2017-2019: India)


SCORE Training will be rolled-out in 10 Lean Manufacturing Competitiveness Scheme (LMCS) clusters, covering approximately 100 - 120 MSMEs under the special name 'Lean Plus Make in India MSME Cluster Scheme' (Lean+MII). This scheme is a Government initiative to reduce waste in manufacturing and will be implemented in priority sectors identified under the Government of India's Make in India initiative.

Efforts will focus on institutionalization and sustainability of SCORE in the country.
