A virtual event took place on 21 January 2021 to launch the International Year. The ILO Director-General, Guy Ryder, UNICEF Executive Director, Henrietta Fore, the Nobel Peace Laureate, Kailash Satyarthi and child labour survivor and activist, Amar Lal participated at the launch event.

The COVID-19 crisis has brought increased poverty to already vulnerable populations and may reverse years of progress in the fight against child labour. School closures have aggravated the situation and many millions of children are working to contribute to the family income.

Throughout the year, a number of events will raise awareness of this problem that affects one in 10 children worldwide.



Report: Road map for Development of Policy Framework for the Inclusion of Internal Migrant Workers

ILO commissioned this report in October 2019 as a part of the effort to revive the deliberations towards the inclusion of internal migrant workers in the discourse of national development planning.

Pillars of ILO's response

Stimulating the economy and employment

► ILO-IFAD held a joint meeting with the National Rural Livelihood mission, Ministry of Rural Development to follow up on the concept of rural livelihood recovery fund in December 2020.

2 Supporting enterprises, jobs and incomes

- ► Technical advice was provided to Ministry of Skill Development and Entrepreneurship to design the curriculum for their proposed entrepreneurship scheme. It will contribute to National Institute for Entrepreneurship and Small Business Development (NIESBUD) in their efforts to promote employment. ILO is a technical partner of the institute.
- A technical consultation on 'Decent Work for Child Care Workers in India' was organized in December 2020. It witnessed participation from key Ministries of the Government of India, including Labour, Skills, MSME, Rural Development and

- Women and Child Development ministries. Central Trade Unions, Employer's organizations and other UN agencies participated at the consultation as well.
- During the consultation, key findings of the ILO-Centre for Women's Development (CWDS) study on the national crèche scheme were presented and way forward was discussed.
- ► A presentation on key findings of study 'Challenges opportunities for productive employment and decent work in the natural stone mining industry supply chain in Rajasthan" was made at the global meeting organized by SECTOR department of the ILO with the Flanders and Steering Committee of the joint Dutch/ Flemish TruStone Initiative and Dutch Social and Economic Council. study The undertaken by the Natural Stone mining project,.
- ➤ Sustaining Competitive and Responsible Enterprises (SCORE) module of the ILO was cascaded among Amazon suppliers by the Federation of Indian Chambers of Commerce & Industry (FICCI) in Dec 2020. The training incorporated modules on

- workplace cooperation, quality and Occupational Safety and Health (OSH). ILO experts and officials provided orientation on SCORE to managers and workers from the participating enterprises.
- ▶ Study towards "Developing business case for good Industrial Relations practices in response to COVID-19 pandemic" was initiated. This is aimed to serve as a basis for enterprises to improve their respective Industrial Relation (IR) practices.

3 Protecting workers in the workplace

► At the 'Stakeholders Consultation on Building a Migration Network in India' organised by the India Centre for Migration and Ministry of External Affairs, ILO representatives provided their expertise along with the scholars and practitioners working in labour migration and diaspora issues. It aimed at identifying areas of collaboration between ICM and academia, think tanks,

Relying on social dialogue for solutions

- ► Training programme on the introduction of study 'Empowering Women in Public Sector Enterprises- Adoption of Work from Home (WfH) Model' was organized in Dec 2020. ILO and Standing Conference of Public Enterprises (SCOPE) jointly organized three training programs with 15 member task force members who will engage with the participants of the study.
- ► To support "Establishment of Enterprise-Level COVID-19 Task Force", first session of the Training of Trainers (TOT) was held with social partners (30 participants from trade unions and employer organisation representatives).

3-week training had an objective of working together on strengthening partnerships. It is imparted by International Training Centre of the ILO-Turin and ILO-India.
