OUTCOME OF THE 2ND SESSION OF THE JOINT WORKING GROUP

Cooperation of the three Secretariats on ship recycling matters

SUMMARY

Executive summary: This document provides information on actions requested of the three

Organisations by the JWG at its second session.

Cooperation of the three Secretariats on ship recycling matters

- At its second session, the Joint Working Group requested that the Secretariats of the Basel Convention, International Maritime Organization and International Labour Organization report back to the third session on actions requested of the three Organisations by the JWG. The JWG at its second session, having taken into account the information provided on the technical cooperation activities on ship scrapping launched or planned by the three Organisations, agreed to:
 - .1 recommend that each Organisation invite the other two to participate in the workshops or seminars organised by the Organisation;
 - .2 recommend that each Organisation include in the programme of its activities a section providing information on the Guidelines of the other two Organisations;
 - .3 recommend that the Secretariats of the three Organisations make efforts to enhance coordination and cooperation in the organisation of such activities.
- This document provides a summary of the actions undertaken by the three Secretariats as recommended by the Joint Working Group.

Activities undertaken by the three Secretariats

The following table provides a breakdown of the activities undertaken and meetings held by each Organisation, and the participation of the other two Organisations. Reference should be made to document ILO/IMO/BC WG 3/3/1 entitled "Global Programme for Sustainable Ship Recycling" for details of the efforts taken by the Secretariats of the three Organisations to enhance coordination and cooperation in the organisation of activities.
