

Approach to Employment Injury (EI) compensation benefits in the EU and OECD

The benefits of Employment Injury protection can be divided in three main groups. The cash benefits include disability pensions, survivor's pensions and other short- and long-term financial help. The medical benefits include drugs, medical visits and other short- and long-term health care. The rehabilitation benefits include physical rehabilitation, but also re-training or career-change support.

The 35 member states of the European Union (EU) and the Organisation for Economic Cooperation and Development (OECD) differ in the ways they provide Employment Injury Insurance benefits. Some, like Israel, have an all-encompassing Employment Injury scheme that provides cash, medical and rehabilitation benefits. Others, like the Czech Republic, includes the medical and rehabilitation benefits in their Health insurance. And some, like France, have more than 15 different schemes providing cash benefits for a variety of special cases.

Presented here is an overview of the ways the EU and OECD members provide Employment Injury benefits.

iii In Croatia, permanent disability cash benefits are provided by the standard pension fund, and temporary disability cash benefits are provided by the Employment injury scheme. However, the pension scheme included temporary cash benefits for rehabilitation purpose.

iv The French system has 18 schemes that includes Employment Injury cash benefits (including standard Social Security).

v The Employment Injury scheme is part of the Health insurance system.

vii New Zealand has cash benefits in its Accident scheme for all accidents. Those benefits can be augmented by benefits from a public-carrier employer-liability scheme in case of work-related injury.
