FIFTEENTH ITEM ON THE AGENDA

Report of the Director-General**Fourth Supplementary Report: Incomplete delegations at tripartite meetings**

1. Acting on the resolution concerning the strengthening of tripartism in the overall activities of the ILO, adopted by the Conference at its 56th Session (1971), the Governing Body requested the Director-General to carry out inquiries concerning the failure of governments to send tripartite delegations to sessions of the General Conference, regional conferences and industrial committees¹ and to report to it on this subject.
2. At its 205th Session (February–March 1978), the Governing Body, on the recommendation of its Officers, decided to authorize the Director-General to extend the scope of the inquiries to cases of failure to send any delegations at all.
3. The last report on the subject was submitted to the Governing Body at its 280th Session (March 2001). The following report covers the 90th (June 2002), 91st (June 2003), 92nd (June 2004), 93rd (June 2005), 94th (Maritime – February 2006) and 95th (June 2006) Sessions of the Conference, as well as the Tenth African Regional Meeting (December 2003), the Seventh European Regional Meeting (February 2005), the 16th American Regional Meeting (May 2006) and the 14th Asian Regional Meeting (August 2006).
4. The Office decided only to carry out inquiries concerning governments which had failed to send complete tripartite delegations to several sessions of the International Labour Conference, or to a Regional Meeting. Thus, letters were sent to 55 Governments, eliciting only 18 replies.
5. The tables in the appendix indicate the absent or incomplete delegations at the meetings concerned and summarize the explanations received from member States. The replies referred primarily to financial constraints.
