Protecting workers against avian influenza

The International Occupational Safety and Health Information Center (CIS) has made a list of selected internet resources providing information on the protection of workers against avian influenza. Prepared and made available by international and national organizations, the documents and guides address risks when working with poultry, in laboratories, as airline crews, etc. Control measures involve using appropriate protection, taking precautions and educating workers in order to prevent an outbreak in the human population.

The list of resources listed below was last updated on 14 July 2006.

 Description: Addresses the key issues surrounding detection, response, containment, and impact mitigation in the event of an influenza pandemic.

 Description: Provides guidance to facilitate rapid detection and assessment of potential "signals" that the virus is improving its transmissibility, and to guide implementation of effective response interventions before an emerging pandemic virus has spread beyond an initial outbreak zone.

 Description: Based on the WHO global influenza preparedness plan (listed above), the PAHO plan takes a multisectoral, phase-specific approach to planning for an influenza pandemic and emphasizes the need for joint action among authorities in health, agriculture, emergency response, and other sectors, as well as with civil society and the private sector.
